The Legislative/Advocacy Committee submits position statements to the AAA Board for approval. Those positions establish the basis for action on public policy issues. Positions taken by the Legislative/Advocacy Committee shall reflect the approved Dane County Legislative Agenda. The Legislative/Advocacy Committee may also make recommendations to the AAA Board on evolving senior issues. The AAA Board Chair shall appoint all members of the Legislative/Advocacy Committee. At-large member appointments must be approved by the full AAA Board. At least two (2) members of the committee shall be members of the AAA Board. All committee members shall be residents of Dane County and a majority of each committee shall be 60 years of age or older. Committee members shall serve three (3)-year terms. A Chair and Vice-Chair shall be elected by the Committee and have voting rights. (See *Committee Job Description* for additional info)
