**Ted Bunck**

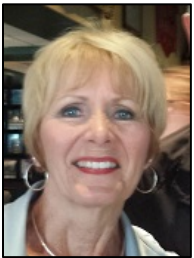

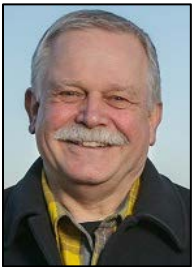
**Bill Clausius**
