## Support for Caregivers in 2018

In 2013, the AARP reported 578,000 caregivers in Wisconsin provide 538 million hours of unpaid care to older adults and children and adults with disabilities. The estimated value of this unpaid care is \$7 billion. The personal cost to family caregivers is inestimable, and includes less time on the job, lost wages, worsening health and social isolation. Since that time, the scope of care provided and the need for support of family caregivers has continued to grow rapidly.

We look forward to supporting caregivers in 2018! Moving forward, recognition of the contributions made by Wisconsin's family caregivers resulted in significant action. This past November, Wisconsin Celebrated National Family Caregiver Month by forming the Wisconsin Family and Caregiver Support Alliance.

The new statewide alliance is dedicated to:

- Engaging employers and creating support for employees providing care for family members
- Expanding respite care options statewide
- Improving navigation and access to caregiving or family support resources
- Expanding future Planning/Advanced Planning for all residents

At Dane County we share these goals. In 2017, we continued outreach to local employers. I am available to present to employees at venues like "Lunch and Learns" to educate working caregivers. I have also met with health and wellness professionals, Employee Assistance Programs, and other groups interested in supporting staff providing care to family, friends, and neighbors. Increased outreach, aided by Dane County's Caregiver Alliance, continues to expand that work.

In 2017, we continued to address caregiver stress and fatigue through supporting grants to our affiliated support groups, and we convened a Mindfulness Meditation Class for Caregivers. A detailed description of the most comprehensive Dane County program, the *Caring for Caregivers* grants, is described in detail on page 2.

The nation-wide shortage of paid caregivers became noticeable for grant recipients at the end of 2017. Area Agency on Aging staff met with providers to discuss how we can more efficiently partner to provide support through the *Caring for Caregivers* grant program. We have also continued to work with Dane County's unique case management program to ensure caregivers receive the appropriate services and expand future planning.

On the national stage, the Recognize, Assist, Include, Support and Engage (RAISE) Family Caregivers Act sponsored by Senators Tammy Baldwin and Susan Collins of Maine passed the US Senate. It calls for the private and public sectors to recommend actions that communities, government, providers, and others can take to make it easier for caregivers to coordinate care and receive information, referrals, and resources.

## Caring for Caregivers Grants Available for 2018

Dane County's *Caring for Caregivers* Program administers grants funded by the National Family Caregiver Support Program (NFCSP). The \$750 grants are intended to support Family Caregivers in the work they do to help the older adults in their lives age in place. Recognizing the need for respite and supplemental services, the program provides for a variety of caregiver supports such as personal cares, home chores, personal emergency response systems, home modifications, adult day care and more. These services are provided for the care recipient as a means to provide respite to family caregivers. Grant funds are also available for direct respite and support to caregivers in the form of self-care services such as meditation classes, complementary medicine services, and more.

Caregivers are eligible for the grants based on the age and status of the person for whom they're providing care. Older adult care recipients must be Dane County Residents aged 60+ or of any age if there is a physician's diagnosis of Alzheimer's or dementia. There are also grants available to older adult caregivers aged 55+ if they are parents or other relatives of a severely disabled adult child aged 19 – 59, or if they are grandparents or other relatives raising grandchildren under age 18. There is no financial means test to qualify for the grants.

*Caring for Caregivers* grants are intended to be one-time awards to help caregivers through challenging times and to get needed services in place. They are not intended to be ongoing from year to year. Caregiver recipients may be eligible in subsequent years if they require a different service to help their loved one remain at home. Grants are intended to help those with immediate need, so services must begin within two months of receiving the grant award or funds will be reallocated.

If you are a caregiver who needs support and assistance, and you are interested in applying for a grant, the best way to do so through case management. Meeting with a case manager will ensure you receive help tailored to your situation and caregiving needs and it provides follow up for grant services. In 2017 we saw great attention to the needs of families and caregivers in our state: from statewide expansion of Family Care/IRIS long-term care programs and supports for caregivers with loved ones experiencing dementia, to a biennial budget investment in wage increases for the direct care workforce and the end of a waiting list for more than 2000 children with significant disabilities.


